- A member shall cease to be a member of the Association:

- In addition to one time entrance fees, annual subscription fees linked to enrollments are payable quarterly.
- Associate members shall have a varying fee as indicated below:
 - Direct Sales Associates & individuals: One time entrance fee of Rs 5000 + annual subscription fee of Rs 5000
 - Others: One time entrance fee of Rs 10000/- + annual subscription fee of Rs 10,000/-
- Entrance fees / subscription fees are payable as applicable at the time of submission of application.
- All applications seeking memberships will be subject to the approval of the AIRDA Executive Committee as per the existing Rules & Regulations of the Association.
